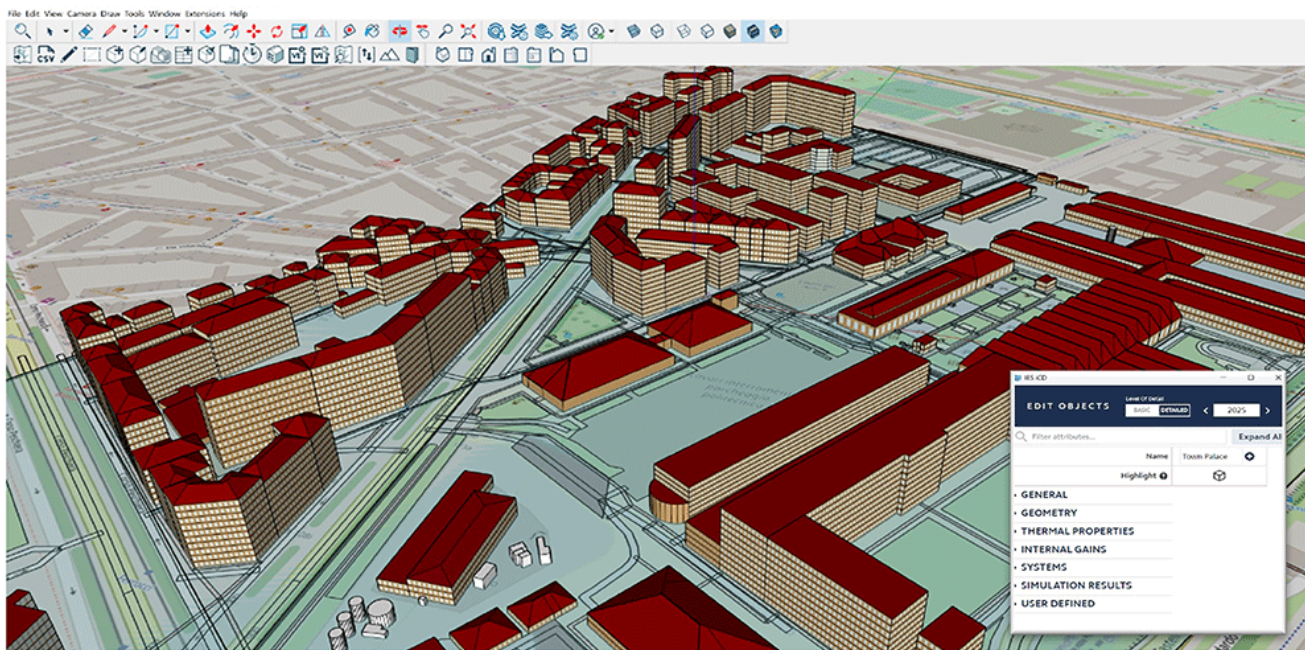

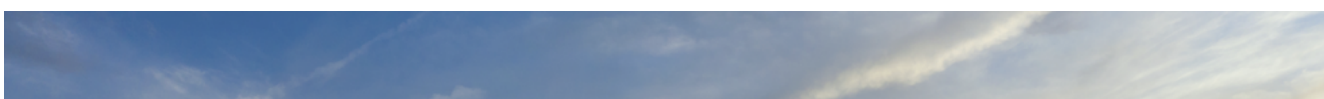

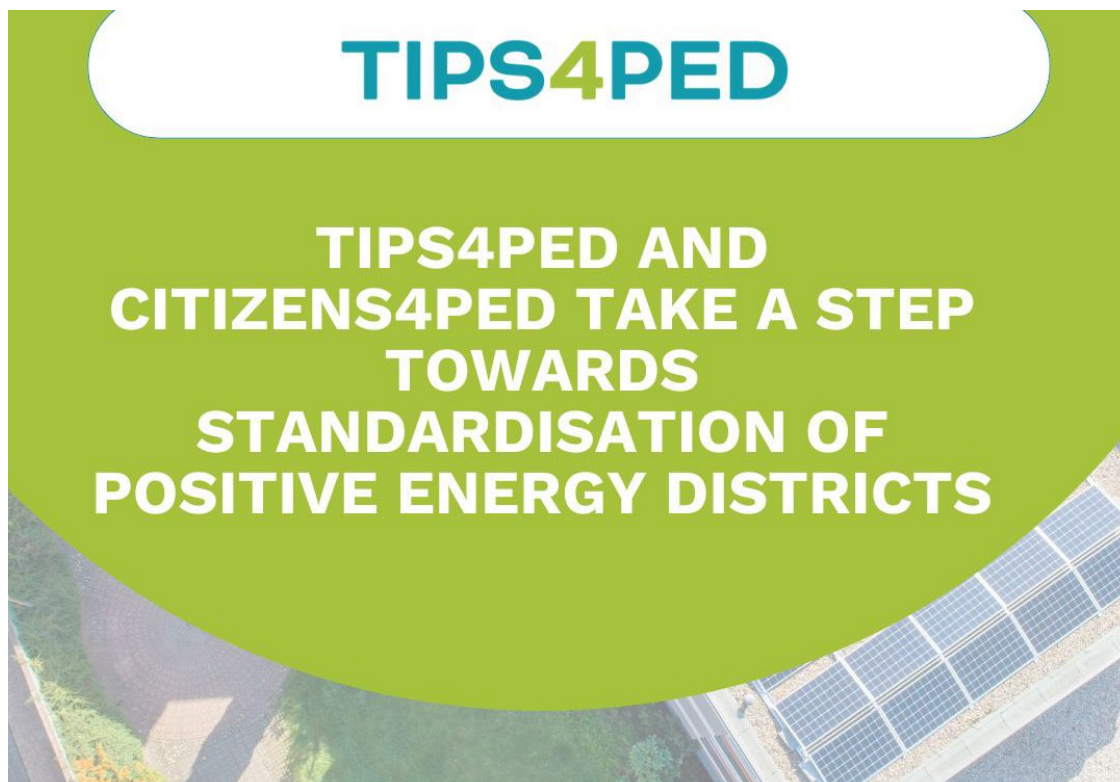

New report shows how standards support climate-neutral urban development

TIPS4PED and Citizens4PED take a step towards standardisation of PEDs

Two new CEN Workshop Agreements on PEDs are being developed through the Citizens4PED and TIPS4PED projects, addressing complementary aspects: citizen-led renewable energy communities and data-driven decision support through digital twins.
